School Board Update



Summary of School Board Committee Meetings Provided by Committee Members

February 2009

Education Committee

The Education Committee met on February 10th. The Committee received reports on testing. The administration presented testing data from the Educational Record Bureau (ERB) test; Pennsylvania System of School Assessment (PSSA) and Scholastic Assessment Test (SAT). T/E students consistently performed above the suburban norm and national norm on the ERB test. In addition, T/E had a higher percentage of students score in the 'advanced' and 'proficient' category on the PSSAs when compared to state percentages. Finally, Ninety-five percent of 2008 seniors took the SAT. The mean verbal/reading SAT score was 580 and the mean math score was 594.

Next, the administration presented information on Adequate Yearly Progress (AYP). In 2008, all T/E schools made AYP. In 2008, AYP was determined using PSSA results from grades 3-8 and grade 11. The percentage of students who scored advanced or proficient in math, in grades tested, ranged from 80.8% to 95.7%. The average AYP performance standard in math is 56%. The percentage of students who score advanced or proficient in reading ranged from 81.7% to 96.4%. The average AYP performance standard in reading is 63%. By 2014, the state expects 100% percent of students to score in the proficient category.

Facilities Committee

The Facilities Committee met on February 20th. The Committee outlined and discussed the goals for the upcoming year.

The District architect is currently working on the design and construction documents for a renovation to Devon Elementary School. The District will receive bids for the project in early April.

The Committee discussed the process of installing and updating the District's network cabling system at the IT building. The project was designed to allow for growth in technology in accordance with the strategic plan.

The Committee agreed to move to the consent agenda of the February 23rd Board meeting an agreement with Tri-M Group, LLC to provide network cabling at the IT building in an amount not to exceed \$154,500. The Committee also agreed to move to the consent agenda an agreement with TeraNet Consulting & Technical Services for project management services for the upgrade to the District-wide telephone system and the consolidation of WAN services in an amount not to exceed \$7,500.

The Committee and administration reviewed the process used to update the Infrastructure report each year and to prioritize projects.

In preparation for its sidewalk project, Tredyffrin Township needs District approval to regrade a portion of District property. The Committee agreed to allow the Township to regrade a portion of District property, assuming any storm water management issues can be resolved.

Finally, the contract between Tot-Time Kids (formerly a Child's Place) and the District is coming up for renewal. The Committee asked the administration to determine the costs incurred by the District in allowing Tot-Time Kids to use District facilities.

The Committee will meet next on March 13th at 7:30 a.m. in the Tredyffrin Easttown Administration Offices.

Finance Committee

The Finance Committee met on February 19th. The administration presented the monthly financial statements for January. The administration explained that transfer tax and delinquent tax revenue is lower than the prior year, while investment income revenue is higher than expected. It was also noted that the final lien list is substantially higher than last year.

The Committee reviewed draft goals. A revised list of goals will be discussed at the March meeting.

The District has the option of joining the Delaware Valley Health Care Coalition (DVHCC), which is a

consortium of local union health and pension funds. By joining the consortium, the District would be eligible to receive discounts on healthcare benefits. The administration will research this issue and provide additional information at the March meeting.

The administration presented recent District initiatives to reduce energy consumption. The District is forming an energy management committee to further evaluate ways to reduce energy consumption.

Since the January Finance Committee meeting, the administration has implemented several initiatives to reduce spending to match reduced revenue projections. The administration presented revised expenditure data for the remaining portion of the 2008-2009 fiscal year.

The administration will review the District's fees charged for facilities use. In addition, the administration will keep track of all costs, including labor, to provide public records under Pennsylvania's Right to Know Law.

Policy Committee

The Policy Committee met on February 5th. The following policies will be sent to the full Board for a second reading at their regular meeting on February 23rd: Policy 4340, *Restriction on Use of Electronic Devices (Tredyffrin/Easttown School District Employees)*; Policy 5100, *Special Education*; Policy 9130, *Officers of the Board*; Policy 9140, *Board Committees*; Policy 9220, *President – Inability to Complete Term*; Policy 9318, *Preparation and Distribution of Information Prior to Board Meetings*; and 9420, *Duties of Bonding Officers*.

The Committee recommended that Policy 2110, *Superintendent as Executive Officer*, be revised and then sent to the full Board for a first reading in February.

The Committee reviewed Policy 5119, *Foreign Students and International Exchange Study Program*. No changes were made and the addition of a new review date was recommended. In addition, the Committee reviewed Policy 5437, *Continuing Education for Pregnant Students*. The Committee determined that this policy is outdated and is no longer needed. The policy will be sent to the full Board for a first reading with intent to repeal.

The Committee recommended that the following policies be reviewed or discussed at the March 12th Policy Committee Meeting: Policy 1124, *Distribution of Promotional Information*; Policy 6121, *Philosophy of Education*; Policy 6162, *Instructional Materials – Copyright*; Policy 5440, *Free or Reduced Lunches*; Policy 5450 *Advisory Health Council*; and Policy 5510, *Post-Secondary School Students*.

The Committee asked the District solicitor to write a resolution that authorizes the replacement of the word "pupil" with the word "student" wherever it occurs in Board policies and regulations.

After a brief discussion, the Committee affirmed their support for teacher participation in "Casual Business Dress Days" that generally occur once a month, to raise money for local charities. The Committee also indicated support for student participation in the Google art contest.

Public Information Committee

The Public Information Committee met on February 5th. The Committee reviewed Pennsylvania's new Right to Know law with the District solicitor. The Committee recognized that the District's current policy and procedure outline how requests for information are fulfilled and that the new Right to Know law will not alter our practice. The Committee discussed the need to develop the criteria to determine what information could be posted on-line. Betsy Fadem suggested that we gain some experience in the type of information requested from the community to determine if posting on-line is the best solution. Continuing, Mrs. Fadem stated, T/E is recognized as a leader in education, and is in compliance with the Right To Know law but that more experience and knowledge are needed to understand the implications of posting the information on-line.

The Committee discussed developing a legislative advocacy communication plan based on the communication methods used for disseminating information about the Graduation Competency Assessments last year. This purpose of the plan will be to guide the District in communicating about future legislation affecting the T/E School District.

The Committee discussed the possibility of using Twitter.com as a complement to TE All-Call. Committee members were asked to visit Twitter.com prior to the March meeting in order to further discuss it's viability as an emergency communication tool.

Beginning in 2009-2010, the administration will provide the District calendar in a comma separated value (CSV) format for download on the TESD web site. The CSV version of the calendar will contain the same activity and event information that is printed on the paper copy of the calendar and will not be updated for scheduling changes.

Education Committee, Chair: Debbie Rollins

The Education Committee met on March 17th. The Committee heard a review of reading and math support, K-12. The PSSA math support and literacy support programs will be redesigned for efficiency and will include more technological and electronic learning tools.

The administration received a report on 2009-2010 staffing recommendations and variations on class size policy. The Committee will recommend to the full Board that straight-line progression enrollment data be used in budgeting assumptions when projecting future class sizes. Staffing requests in the budget will be revised to reflect this change.

The administration presented a modification to the 2009-2010 school year calendar. The full day inservice scheduled for April 16, 2010 has been moved to March 26, 2010, the Friday before spring break, to accommodate the state PSSA testing window. A summary of the calendar is available on the TESD web site.

Finally, the Committee received an update on graduation competency assessments (GCAs.) On March 4th, an agreement was reached to change the name of the proposed end-of-course exams from graduation competency assessments to Keystone Exams. The implementation timeline was delayed one year to be applied to the class of 2015 and beyond.

The Facilities Committee met on March 13th. The Committee agreed to move to the consent agenda of the March regular Board meeting the acceptance of bids for

the renovation of the MDF and IDF rooms at the middle and elementary schools.

The District will receive bids for the renovation project at Devon Elementary School in early April.

The Committee was notified that Tredyffrin Township received a grant to construct a green roof within the Township. The Township had hoped the green roof could be constructed at Hillside Elementary School. The Committee asked the administration to research several concerns about the construction of the roof at Hillside.

The Finance Committee met on March 16th. The Committee reviewed the financial statements. The administration noted the continued decline in transfer tax revenue. However, due to a significant reduction in spending the District will finish the fiscal year with a balanced budget. The Committee and community members discussed various issues affecting the budgeting process, including past and present tax rates, the impact of Act 1, and the use of bonds to fund construction projects.

The administration presented information about the 2008-2009 food services budget. Operating revenues are lower than expected, however the cost of food and supplies are lower than budgeted. In April, the administration will present a Food Services capital investment plan.

The Committee asked the administration to keep track of all costs to provide District records under the Right to Know law, including labor costs.

The Committee agreed to move to the consent agenda of the March regular Board meeting its decision to allow the District to join the Delaware Valley Health Care Coalition.

Federal stimulus monies aimed at education are coming to our state and directly to the T/E School District. T/E should receive a total of \$1,099,440.00 in stimulus monies to be primarily spent on Special Education (IDEA). The monies will come to the District over a two year period and will be applied to the 2009-2010 and 2010-2011 academic years.

Many parents have heard about the state's idea to consolidate school districts from 500 to 100. There is a lot of concern out there over this proposal, and there does not appear to be much support from local legislators. If this idea were to move forward it would increase the average size of school districts to 17,000 students. The Committee will monitor this movement and provide updates as they become available.

Thanks to an outpouring of citizen opposition to the state's plan to implement Graduation Competency Exams (GCAs) the legislature passed a one year moratorium during which time GCAs could not be further developed. All of our local state senators and representatives remain opposed to the original GCA plan. Now, the Pennsylvania Department of Education has come forward with a new plan to re-name the GCAs the Keystone Exams. There are some differences but many similarities between these plans. As information continues to become available, the Committee will share it with the community. The Board remains opposed to spending more classroom time preparing for and administering state exams; is committed to providing alternative assessments for students who are diverse learners; and is opposed to the extraordinary amount of money necessary at both the state and local levels to develop and administer additional state-wide exams.

The Committee recommended that the following policies be reviewed or discussed at the April Policy Committee Meeting: *Policy 1124, Distribution of Promotional Information*; and *Policy 9313, Video Recording of School Board Meetings by the District*.

The Public Information Committee met on March 4th. The Committee reviewed a draft legislative action plan for the purpose of guiding the District and other organizations in disseminating information about future legislation that could have a direct impact on the T/E School District. The plan will be revised and reviewed at the April meeting.

The Committee recommended that the administration conduct a survey on communication methods to obtain feedback from parents and taxpayers on the best ways for the District to communicate on a regular basis. The survey will be conducted this spring.

The April *T/E Board Talk* program will include segments on testing data; student enrollment and facilities use; and the District's communication survey.

The Committee will discuss the topic of posting requested public records on-line at a future meeting.

News From the Art Room

In our study of art fourth grade students learn about the work of artists who make a social statement through their art.

In a recent project we focused on recycling. Recycling involves processing used materials into new products, to reduce consumption of raw materials, energy, and waste disposal.

We invited local artist, David Gerbstadt, to come to BES to talk about his art. This school year TESD, BES and the HSA at Beaumont sponsored him as our artist in residence. Most of his art is created from found materials that he recycles in fun ways. He worked with the 4th grade students on our recycling project. He shared how he gets ideas for his art, the toughest part of any project! Using our computer Smartboard he drew his signature characters, lively monsters and fish each having a unique personality. He drew and talked and drew and drew and drew. Then he brought in his own art, both BIG and small, of these characters made from recyclables. They were constructed of everything from old TVs to plumbing supplies and everything in between. His message to the kids is, "Go ahead, draw, I dare you!"

After this inspiration each 4th grade artist sketched in his/her sketchbook developing his/her own character (person or animal), then constructed that character out of found materials-cardboard, egg crates, old boxes, tubes, string, yarn, and fabric. Students were instructed to design both the front and back of their artwork. The results speak for themselves! Artwork is on display hanging in the windows outside the art room.

More about local artist, David Gerbstadt.

David is a resident to Berwyn, Pa. He attended local schools and received a BFA from Millersville. He thinks art. He breathes art. He lives art. He even drives around in his handpainted art mobile ☺

Last year we were in the process of trying to get him here to talk to the students about being an artist, when he was seriously injured in an accident nearing losing his life. He is known for "mail art", postcards sent with original artwork to encourage art. So during his convalescence each child at BES made a "mail art" postcard and we sent them in big batches to help him in his recovery☺ Using his characters illustrating positive character traits he is painting several large paintings for our Large Group Room. They are a work in progress and expected soon.

February marks World Language Month. Teachers from around the District highlighted the learning of languages and their importance in different ways. At Beaumont Elementary School students celebrated World Language Month by exploring familiar and universally beloved classics of children's literature in Spanish. Devon Elementary students started off the morning with announcements in their native tongue. Letters were sent home and students in each grade level were asked to practice a phrase in their first language. This provided a connection between languages, as well as two programs, ESL and FLES. Students at Valley Forge Elementary were asked to make posters promoting second and third language learning and to indicate its value. Also the ESL and FLES teachers collaborated to promote the many languages already spoken in the elementary schools. This implementation of different cultures has helped to create a more open and diverse climate among our students. We counted 30 different languages!!

In addition, during the month of February, the TE school district welcomed World Language consultants from Princeton, New Jersey to visit World Language classes, from first through twelfth grades. All schools participated in this review. As you may know this marks our eleventh year of having FLES introduced to our students from the elementary level.

The purpose of the visit was to provide the District with ways to articulate the program in order to enhance its delivery and make it most effective for all of our students. Parents, teachers and students were included in the process.

The Tredyffrin-Easttown School District's FLES Program delivers Spanish instruction to students from grades 1 through 5. The FLES curriculum is T/E teacher created; it is part of a program that offers an uninterrupted sequence of language study from first grade through High School AP classes.

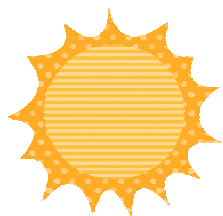

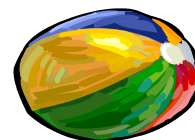

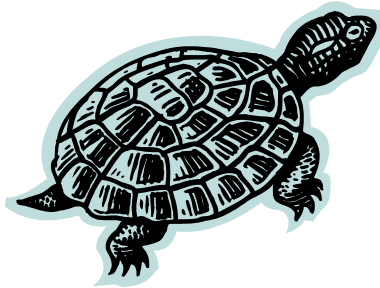
